New Cyber Cafe Rules based on Information Technology (Guidelines for Cyber Cafe) Rules, 2011 - Dated 11th April' 2011

On 11th April' 2011, Ministry of Information Technology, Government of India has issued Guidelines for Cyber Cafes, vide an amendment in I.T. ACT 2000. These Guidelines essentially emphasise on how a Cyber Café needs to operate its business. It is mandatory for Cyber Cafes to ensure 100% adherence to these Guidelines. I.T. ACT Guidelines recommends for a **Digital and Safe Storage of Cafe Log Register** containing every Cyber Cafe Customer's required details along with the information of Computer being used and Websites visited during every Customer Session. All this Information needs to be stored by the Cyber Cafe for a minimum period of One Year. Also every Cyber Cafe needs to submit this Monthly Cafe Log Register Report to the City Law Enforcement Agency by the 5th day of next month.

Keeping above in mind & the **National Security**, we have found that Cyber Cafes can digitally maintain the Cafe Log Register as specified by I.T. 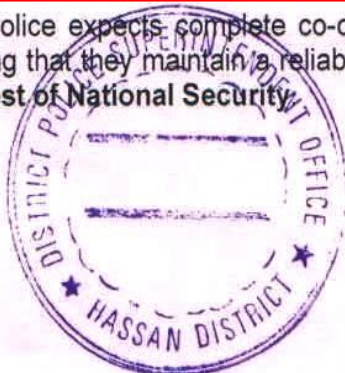
